Announcement Regarding a Petition for Reorganization Proceedings (Reorganization Law in France) by a

Consolidated Subsidiary Located in France

We hereby announce that Eveden Huit SAS (Rennes, France), one of our consolidated subsidiaries, petitioned for reorganization proceedings (Redressement Judiciare) with the Rennes Commercial Court in France on April 1st, 2016, and was ordered to commence reorganization proceedings by such court on April 7th.

Details

1. Grounds for Petition

Eveden Huit SAS is a 100% subsidiary of Wacoal Europe Ltd., and sells Huit branded lingerie and swimwear. The recent price polarization of the lingerie and swimwear market in France and a decrease of the specialty shop channel, has led to a steady decline in sales and mounting losses. Various measures such as improving sales efficiency have been unsuccessful, and after abandoning self-rehabilitation, the subsidiary petitioned for reorganization proceedings.
